The undersigned hereby applies for membership with the CAMARINES SUR II ELECTRIC COOPERATIVE, INC. (hereby called the Cooperative) and in consideration of the acceptance of this application agrees with the Cooperative as follows:

1. The applicant shall pay to the cooperative a Membership Fee of _____ pesos upon filing of this application;
2. The applicant shall when electric energy becomes available, purchase from the Cooperative all electric energy to be used within the premises at the rate charged by the Cooperative, provided however, that the cooperative, may limit the amount of electric energy to be furnished for individual uses;
3. The applicant shall cause his premises to be wired in accordance with the wiring specification of the Cooperative;
4. The applicant shall grant without charge to pay to the Cooperative at its request the necessary rights and easement to the property owned or leased by the undersigned and upon all roads, streets and highways abutting said property, its lines of transmission or distribution of electric energy and will execute and deliver to the Cooperative any conveyance, grant or instrument which the Cooperative shall deemed necessary or convenient for said purposes or any of them. All service line installed by the Cooperative on said property shall at all times be the sole property of the Cooperative; shall have the right to access to said property; to repair service and upon discontinue of said service for any reason, to remove the same. Any appliance and equipment installed on the premises paid for by the member shall belong to him;
5. The undersigned shall have all the rights and privileges granted to members under the charter and By-Laws of the cooperative or any amendments thereof and will comply with and be bound by such charter, By-Laws, rules and regulations which may from time to time be adopted by the Board of Directors of the Cooperative;
6. The applicant by paying a membership fee and becoming a member under the by-laws assumes no personal liabilities or responsibilities for any debts or liabilities of the cooperative and it is expressly understood that under the law his property cannot be attached for any such debt or liabilities;
7. The cooperative shall not be liable in damage to the applicant for failure to supply electricity to said premises under any said condition;
8. That should I be an apartment/ building owner for lease, I hereby bind myself jointly and solidarity liable for all unpaid electric bills of my lessee/tenants and I hereby obligate unto myself to pay all their unpaid electric bills before new connection shall be granted or upon demand by the Cooperative;
9. The approval of the application by the Cooperative shall constitute an agreement between the Cooperative and the undersigned upon terms herein above set forth, and the CONTRACT for Electric Service shall continue in force until cancelled within 30 days' written notice by either party to the other;
10. That finally and as an essential part in the approval of this application for membership that I shall allow during reasonable time of the day or night the representative/employees of the cooperative and upon the latter's demand upon me or any of my household of sufficient age and discretion to enter my premises/residence for the purpose of collection, disconnection, installation, repairing, wiring connection/outlet inspection, load inspection/computation, meter reading, violation of contract or RA 7832 and for any such other purposes related to the cooperative's function. I further agree the refusal on my part or by any member of my household to effect the herein mentioned purposes shall be a ground for the cooperative to immediately discontinue electrical service and/or refusal for further reconnection of electric service, or terminate my membership with the Cooperative.
